Università Politecnica commits itself to ensure insurance coverage to the Phd Student while performing his research and training activity abroad at the Host Institution; scholarship coverage and top-up scholarship for a period abroad to the Phd student (as foreseen under Italian laws and regulations in force); supervision of Maria Gabriella Ceravolo, Full Professor of Physical and Rehabilitation Medicine at the Sending Institution, and PhD student Supervisor, <u>m.g.ceravolo@staff.univpm.it</u>
