# • Report on the Meeting with Associations Involved in the Production of Goods and Services and Trade

Professor Simona Magi informs the Council that on December 11<sup>th</sup>, 2024, at 2:30 p.m., a consultation meeting with the Associations involved in the Production of Goods and Services and Trade took place. The meeting involved the Presidents of the Single-Cycle Degree Courses in Medicine and Surgery and industry representatives. The purpose of the meeting was to discuss the reform of the degree programs as foreseen with Ministerial Decree No. 1649 of December 19<sup>th</sup>, 2023.

## Key topics of the meeting included:

- -professional profiles and career opportunities for graduates;
- -training objectives, assessment methods, and the enhancement of internship experiences.

The meeting underscored the need to adapt the Study Course contents to the aforementioned Ministerial Decree.

The main notable changes included the increase of ETCs for Elective Educational Activities and thesis preparation, internship introduction, as well as the reorganization of courses by reducing the number of integrated ones.

Furthermore, the meeting highlighted opportunities for students in the Medicine and Surgery program to develop competencies in biomedical engineering.



The PTA will be conducted partly in hospital wards and will deal with small group activities. On the other hand, voluntary attendance is an individual activity.

## 6. Regulations

The President shows to all the members of the Council the <u>Specific Study Course Rules</u> and point out one of the main changes, which concern optional exams:

- "...Although elective exams are part of the study plan during the second and third years, students can choose these activities at any time throughout the six-year program, specifically during the annual presentation of the study plan..."
- "...Attendance is not mandatory for elective courses that contribute to the recognition of the second degree in Biomedical Engineering".

The new Specific Study Course rules have been sent to all the members of the council for consultation and will be published on the University website.

## 7. Any other business

No points on the agenda item.

Professor Andrea Tigrini intervenes, reporting unpleasant events that occurred during his lessons. Students often leave the laboratories in deplorable conditions and act disrespectfully towards Professors. He asks what kind of measures can be taken to this end. Professor Simone Pifferi intervenes, saying that if the situation arises the only solution is to refer the situation to the Ethics Committee. Professor Micaela Morettini intervenes, complaining that students often make confusion during classes, making this latter difficult to follow. She also adds that many students scan the presence via QRcode and then leave the class. The student Mayar Bezzai says that the problem of frequencies is mainly due to the fact that lessons are close to the exams and that students are forced to give up the same to study.

Professor Simona Magi encourages students to behave respectfully during classes and in university buildings and asks student's representatives to spread the word to their colleagues.

Having nothing more to discuss, the Study Course Council is closed at 1:53 p.m.
